RE: OMA Request for Review – 2022 PAC 72470

Dear Mr. Snider:

The Public Access Bureau has received the enclosed Request for Review under section 3.5(a) of the Open Meetings Act (OMA) (5 ILCS 120/3.5(a) (West 2020)) from Mr. Barney Bier alleging that the Adams County Board (Board) potentially violated OMA during its May 10, 2022, meeting. We have determined that further action is warranted.

In this Request for Review, received July 1, 2022, Mr. Bier alleged that the Board improperly discussed the salaries of elected officials in closed session on May 10, 2022.<sup>1</sup>

In order to further evaluate this matter, this office requests that the Board provide this office with copies of the agenda, open and closed session minutes (in draft form if necessary), and closed session verbatim recording from its May 10, 2022, meeting for this office's review; this office will keep the closed session materials confidential. This office also asks the Board to respond in writing to the allegation that it violated OMA by discussing elected officials' salaries in closed session because that topic does not fall within the scope of any exception set out in section 2(c) of OMA.<sup>2</sup>

As we review this matter, we will notify you if we require additional records or information. Please note that under OMA, this office is required to forward a copy of any response to the requester and to provide the requester with an opportunity to reply. 5 ILCS 120/3.5(c) (West 2020). The Act also permits the public body to provide a redacted version of its response for release to the requester. Accordingly, if you claim that any portion of your written response is confidential, please send two versions of your response letter: a complete copy for this office's confidential review and a redacted version suitable for this office to forward to the requester.
