**RESOLUTION ESTABLISHING THE SALARY FOR
THE PIKE COUNTY CLERK, TREASURER, CIRCUIT CLERK,
and SUPERVISOR OF ASSESSMENTS**

WHEREAS, Section 5-1010 of the Counties Code [55 ILCS 5/5-1010] requires the County Board to establish the salary of County officers at a meeting prior to the election of the officers whose salary is being established; and

WHEREAS, Section 2(a) of the Local Government Officer Compensation Act [50 ILCS 145/2(a)] requires the salary of elected officers for local governments to be established at least one hundred eighty (180) days prior to the start of their term; and

WHEREAS, Section 2(b) of the Local Government Officer Compensation Act [50 ILCS 145/2(b)] requires the salary of elected officers of a county be set by ordinance or resolution of the County Board; and

WHEREAS, the Pike County Board wishes to increase the annual salary of the County Clerk and Recorder, County Treasurer, the Clerk of the Circuit Court, and the Supervisor of Assessments, by \$1,000 for FY2023, \$1,000 for FY2024, \$1,000 for FY2025, and \$1,000 for FY2026; and

WHEREAS, the Pike County Board wishes to provide health insurance benefits for the County Clerk and Recorder, County Treasurer, Clerk of the Circuit Court, and Supervisor of Assessments equal to that of represented and non-represented full-time employees.

NOW, THEREFORE, BE IT RESOLVED that:

1. The salaries for the elected official positions of County Clerk and Recorder, County Treasurer, and Clerk of the Circuit Court, shall be set as follows:
 - a. The salary for FY2023 is \$57,416.00 effective December 1, 2022;
 - b. The salary for FY2024 is \$58,416.00 effective December 1, 2023;
 - c. The salary for FY2025 is \$59,416.00 effective December 1, 2024;
 - d. The salary for FY2026 is \$60,416.00 effective December 1, 2025.
2. The salary for the elected official position of Supervisor of Assessments shall be set as follows:
 - a. The salary for FY2023 is \$59,416.00 effective December 1, 2022;
 - b. The salary for FY2024 is \$60,416.00 effective December 1, 2023;
 - c. The salary for FY2025 is \$61,416.00 effective December 1, 2024;
 - d. The salary for FY2026 is \$62,416.00 effective December 1, 2025.
3. The expected stipend amounts for the elected official positions of County Clerk and Recorder, County Treasurer, Supervisor of Assessments, and the Clerk of the Circuit

Court are as follows:

- a. The stipend for the County Clerk and Recorder as set by 55 ILCS 5/4-6001 is \$6,500 per year;
 - b. The stipend for the County Treasurer as set by 55 ILCS 5/3-10007 is \$6,500 per year;
 - c. The stipend for the Clerk of the Circuit Court as set by 705 ILCS 105/27.3 is \$6,500 per year.
 - d. The stipend for the Supervisor of Assessments as set by 35 ILCS 200/4-20 is \$3,000 per year if the requirements of that section are met.
 - e. The County has additionally established a stipend of \$4,500 per year to the County Clerk and Recorder for overseeing IMRF, and \$2,800 per year to the County Clerk and Recorder for overseeing risk management.
4. Health insurance benefits will be provided to the County Clerk and Recorder, County Treasurer, Clerk of the Circuit Court, and Supervisor of Assessments equal to that of represented and non-represented full-time employees.
